



Safety in Practice Alumni Network

After three years of supported participation in the Safety in Practice (SiP) programme you now have the quality improvement (QI) skills, knowledge and experience that you need to continue with your ongoing quality improvement journey independently. We hope that these improvements will be undertaken as business as usual within the culture of your team's work.

As a part of the Safety in Practice Alumni Network you will be provided with on-going access to resources and some support. This is to help you sustain the improvements that you have already made, and identify new QI opportunities in other areas. The network will also keep you connected with updates and news in the area of safety and quality improvement. Please note there is no financial reimbursement for involvement in the Alumni Network.

1. Ongoing support provided

As part of the Alumni Network, you will

- Have access to the SiP website and associated resources
- Receive advice and support from the Project Team if required for undertaking your own QI projects (via <u>info@safetyinpractice.co.nz</u>)

1. 1 Safety Culture Tools

As a result of completing the Safety in Practice curriculum you will have completed at least two safety culture tools. You are encouraged to continue to use the resources relating to these tools and apply them to your business as usual. The trigger tool and significant event analysis can be completed at any stage during the year without our involvement. If you wish to complete the safety climate survey the opportunity will be provided on a case-by-case basis at the same time as other teams complete the survey. 1. 2 Learning Sessions and Quality Improvement skills workshop

You are not required to attend learning sessions after transitioning to the Alumni Network. Opportunities to attend quality improvement workshops and learning sessions will be offered on a caseby-case basis. 2.1 Pass rate

A pass rate will add value by assurance that teams leave the programme with the adequate skill set to continue their patient safety journey independently and within the Alumni network. Safety in Practice clinical module data submissions will be monitored at the monthly data management - performance review meetings where teams requiring help will be identified. The project team will monitor teams' data submissions to help identify teams in need of additional support, so to uplift their performance.

Each year teams will be marked against a score card of continuous improvement, teams will need to demonstrate a high enough level of overall improvement to achieve the prescribed pass rate for the Safety in Practice programme.

2.2 Submission of a sustainability plan

A sustainability plan must be submitted to <u>audit@safetyinpractice.co.nz</u> as the final step to becoming a fully accredited Safety in Practice clinic or pharmacy. The sustainability plan demonstrates and describes how you will continue to maintain the changes you have implemented during time in the programme as well as how you will adapt to challenges in the future.
